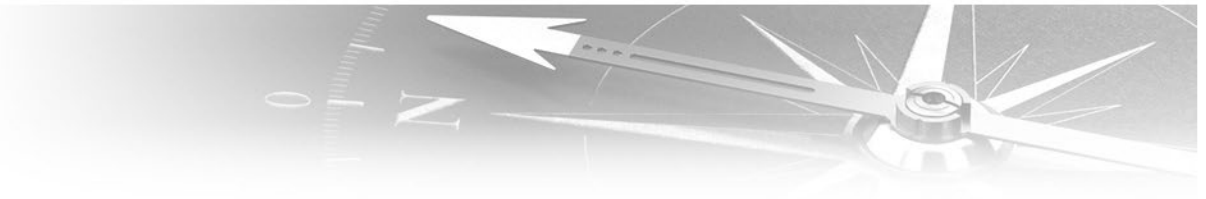

POOL POINT CONSOLIDATOR – FRONTIER SUPPLY CHAIN

Non-Direct - US Consolidation (Pool Point) Loads for Canada

NFI Parts pool point in Elk Grove Village, IL – All States not listed under Direct Ship to NFI Parts’ PDC’s in Canada below are to follow the shipping instructions below to Frontier Supply Chain. Vendors/Suppliers are required to ship these parts to meet the required delivery dates. Please factor a 5 - day transit from the delivery date at the consolidation point to the NFI warehouses in Canada.

Ultimate Destination Location (MB1 or ON1) must be clearly marked on each handling unit / package.

****If shipping from the following locations, suppliers must follow the routing instructions for small parcel or LTL.***

USA to Canada Shipments Only

Vendor Required Customs Documentation for each shipment exporting to Canada: Commercial Invoice, Packing List, and Certificate of Origin

Required Documentation (Invoice, Packing List, COO) must be attached to each shipment in a waterproof envelope.



If Documentation is missing or illegible, NFI Parts will contact the vendor by email and/or telephone to obtain missing documentation.

Your immediate response with submitting this documentation will prevent freight from being delayed and avoid penalty charges at the border for crossing.
